- The European automotive manufacturing industry had total revenues of \$360.5 billion in 2023, representing a compound annual growth rate (CAGR) of 1.5% between 2018 and 2023.
- Industry production volumes declined with a negative CAGR of 4% between 2018 and 2023, to reach a total of 16.8 million units in 2023.
- Germany captured a share of 23.8% of the European automotive manufacturing industry in 2023, making it the largest market in the region. It was followed by Spain and France with 18.1% and 10.4% respectively.
