- The Pakistani automotive manufacturing industry had total revenues of \$4.1 billion in 2023, representing a negative compound annual growth rate (CAGR) of 5.8% between 2018 and 2023.
- Industry production volumes declined with a negative CAGR of 9.6% between 2018 and 2023, to reach a total of 1.3 thousand units in 2023.
- Consumer confidence hit a record low of 26.24 points in September 2023, reflecting pessimism about future economic conditions, rising concerns about unemployment, and a diminished outlook for improved financial situations among households.
