- The Canadian Bakery & Cereals market had total revenues of \$13,782.7 million in 2023, representing a compound annual growth rate (CAGR) of 4.3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2% between 2018 and 2023, to reach a total of 2,317.7 million kilograms in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.4% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$18,782.9 million by the end of 2028.
