- The Chinese Bakery & Cereals market had total revenues of \$59,862.9 million in 2023, representing a compound annual growth rate (CAGR) of 6.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 3.7% between 2018 and 2023, to reach a total of 15,181.1 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.5% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$78,302.7 million by the end of 2028.
