- The French Bakery & Cereals market had total revenues of \$28,314.7 million in 2023, representing a compound annual growth rate (CAGR) of 3.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1% between 2018 and 2023, to reach a total of 5,634.5 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.6% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$32,125.7 million by the end of 2028.
