- The Indonesian Bakery & Cereals market had total revenues of \$5,393.2 million in 2023, representing a compound annual growth rate (CAGR) of 6.6% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.9% between 2018 and 2023, to reach a total of 1,400.8 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.5% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$7,404.2 million by the end of 2028.
