- The Mexican Bakery & Cereals market had total revenues of \$38,882.7 million in 2023, representing a compound annual growth rate (CAGR) of 4.9% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.8% between 2018 and 2023, to reach a total of 13,268.2 million kilograms in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 4.6% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$48,633.3 million by the end of 2028.
