- The Scandinavian Bakery & Cereals market had total revenues of \$10,690.4 million in 2023, representing a compound annual growth rate (CAGR) of 3.5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.2% between 2018 and 2023, to reach a total of 1,767.1 million kilograms in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 3.6% for the five-year period 2023 2028, which is expected to drive the market to a value of \$12,771.8 million by the end of 2028.
