- The South African Bakery & Cereals market had total revenues of \$2,586.6 million in 2023, representing a compound annual growth rate (CAGR) of 5.4% between 2018 and 2023.

- Market consumption volume increased with a CAGR of 1.3% between 2018 and 2023, to reach a total of 1,207.1 million kilograms in 2023.

- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.7% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$3,106.2 million by the end of 2028.
