- Market consumption volume increased with a CAGR of 1.6% between 2018 and 2023, to reach a total of 16,977.8 million kilograms in 2023.

- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 4.1% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$175,093.6 million by the end of 2028.
