- The bank credit segment accounted for the industry group's largest proportion in 2023, with total assets of \$39,212.7 billion, equivalent to 39.6% of the industry group's overall value.
- The growth in revenue of the Asia-Pacific banks industry group is driven by the rising lending interest rates. For instance, in March 2024, the BOJ hiked short-term interest rates to 0-0.1% by a majority vote of 7-2 from the previously held minus 0.1%.
