- The Egyptian banks industry group recorded assets of \$969.4 billion in 2023, representing a compound annual growth rate (CAGR) of 26.0% between 2018 and 2023.
- The bank credit segment accounted for the industry group's largest proportion in 2023, with total assets of \$331.1 billion, equivalent to 34.2% of the industry group's overall value.
- In March 2024, the MPC decided at its special meeting to boost the CBE's overnight lending rate by 600 basis points to 28.25% in keeping with the CBE's continued tightening stance. This hike in interest rate along with substantial loan demand is boosting the interest income of the country's bank industry group.
