- The banking industry involves the activities of banks and similar institutions that offer financial services such as savings, loans, mortgages, and related services to businesses and consumers.
- The Kazakhstani banks industry group recorded assets of \$110.8 billion in 2023, representing a compound annual growth rate (CAGR) of 9.9% between 2018 and 2023.
- The bank credit segment accounted for the industry group's largest proportion in 2023, with total assets of \$59.0 billion, equivalent to 53.2% of the industry group's overall value.
- The growth of the Kazakhstani banks industry group is attributed to the reduction in inflationary pressure which reduced the interest rate and supported the demand for loans. The nation's annual inflation rate decreased slightly from 9.3% in February 2024 to 9.1% in March 2024, which is the lowest reading since February 2022.
