- The Indonesian Fragrances market had total revenues of \$523.0 million in 2023, representing a compound annual growth rate (CAGR) of 3.4% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.7% between 2018 and 2023, to reach a total of 20.3 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.6% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$654.0 million by the end of 2028.
