- The Australian Household Products market had total revenues of \$4,978.6 million in 2023, representing a compound annual growth rate (CAGR) of 2.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.6% between 2018 and 2023, to reach a total of 819.8 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.4% for the five-year period 2023 2028, which is expected to drive the market to a value of \$5,892.4 million by the end of 2028.
