- The Indian Household Products market had total revenues of \$7,955.0 million in 2023, representing a compound annual growth rate (CAGR) of 9.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4.5% between 2018 and 2023, to reach a total of 4,415 million units in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$11,137.0 million by the end of 2028.
