- The Indian internet access market recorded revenues of \$11.0 billion in 2023, representing a compound annual growth rate (CAGR) of 29.3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 10.1% between 2018 and 2023, to reach a total of 915.1 million internet users in 2023.
- The Indian internet access market is driven by various governmental initiatives such as the Digital India Campaign and BharatNet. Also, in 2023, the Minister of Electronics and Information Technology announced its plans to invest \$13 billion in BharatNet to advance connectivity and provide affordable internet access in rural areas.
