Summary

Key Highlights

- The Internet access market includes all Internet service revenues collected to provide narrowband and broadband Internet access through consumer and business channels. All revenues calculated are retail revenues that are exclusive of taxes. Only fixed communication is included, and mobile phone connections are not considered.
- The Spanish internet access market recorded revenues of \$5.0 billion in 2023, representing a negative compound annual growth rate (CAGR) of 0.4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.5% between 2018 and 2023, to reach a total of 46.0 million internet users in 2023.
- In 2023, the Spanish internet access market witnessed an annual growth of 6.4%. The growth is attributed to the rise in broadband access across the country. According to GlobalData analysis based on information from the World Bank, in 2023, the number of broadband subscribers in the country reached 17.2 million, up 1.3% annually.
