All revenues calculated are retail revenues that are exclusive of taxes. Only fixed communication is included, and mobile phone connections are not considered.
- The US internet access market recorded revenues of \$128.5 billion in 2023, representing a compound annual growth rate (CAGR) of 10.7% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 3.1% between 2018 and 2023, to reach a total of 307.2 million internet users in 2023.
- In 2023, the US internet access market witnessed an annual growth of 6.9%. The growth is attributed to the rise in broadband access across the country. According to GlobalData analysis based on information from the World Bank, in 2023, the number of broadband subscribers in the country reached 128.2 million, up 2.6% annually.
