#### Summary

#### Key Highlights

- The mobile phones market includes mobile phone service revenues and average minutes of usage (MOU). Market values include revenues from mobile service providers and other members of the mobile service value chain for the provision of mobile telephony services, excluding revenues from the sale of devices. Market volumes cover prepaid and postpaid, which consist of prepaid average monthly MOU and postpaid average monthly MOU. Minutes of use are made up of the average of voice minutes used in mobile subscriptions, including both incoming and outgoing calls, but not including M2M/IoT voice services.
- The Chinese mobile phones market had total revenues of \$142.5 billion in 2023, representing a compound annual growth rate (CAGR) of 0.4% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 8.5% between 2018 and 2023, to reach a total of 551.6 average MOU in 2023.
- The Chinese government and major telecom carriers have made large investments in 5G technology, which is projected to dramatically improve mobile service capabilities and user experience.
