- The passenger rail sector consists of all passenger transport by 'heavy rail' services, including international, inter-city, regional, and suburban trains ("Commuter trains" in US terminology are included). However, light rail, tram/streetcar, metro/subway, and similar trains are not included.
- The French passenger rail sector recorded revenues of \$12,372.7 million in 2023, representing a compound annual growth rate (CAGR) of 8.2% between 2018 and 2023.
- Sector consumption volume increased with a CAGR of 3.3% between 2018 and 2023, reaching 107,890.0 thousand passenger kilometers (PKM) in 2023.
- France held 13.1% of the market share in Europe in the 2023.
