- The Kazakhstani power generation industry recorded revenues of \$314.6 million in 2023, representing a compound annual growth rate (CAGR) of 1% between 2018 and 2023.
- Industry production volume increased with a CAGR of 0.7% between 2018 and 2023, to reach a total of 95,880.0 gigawatt hours (GWh) in 2023.
- Kazakhstan held a share of 0.03% of the Asia-Pacific's power generation market in 2023.
