- The South American power generation industry recorded revenues of \$61.1 billion in 2023, representing a compound annual growth rate (CAGR) of 3.1% between 2018 and 2023.
- Industry production volume increased with a CAGR of 2.1% between 2018 and 2023, to reach a total of 1,007,388.2 gigawatt hours (GWh) in 2023.
- Brazil held the largest share of 50.7% of the Americas power generation market in 2023, followed by Chile at 20.2%, Argentina at 14.0%, Colombia at 9.95 and Peru at 5.3%.
