- The telecommunication services market is defined as the total volume and value of both the fixed line and the wireless telecommunications market. The market volume here is defined as the number of fixed-line and wireless subscriptions.
- The Australian telecommunication services market recorded revenues of \$17.3 billion in 2023, representing a negative compound annual growth rate (CAGR) of 3.1% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.1% between 2018 and 2023, reaching a total of 58 million subscriptions in 2023.
- The decline in market value is largely due to increased regulatory pressure on companies to lower prices and improve service quality. The Australian government and regulatory bodies imposed measures to ensure fair competition and protect consumer interests, which included capping fees and mandating transparent pricing.
