- The telecommunication services market is defined as the total volume and value of both the fixed line and the wireless telecommunications market. The market volume here is defined as the number of fixed-line and wireless subscriptions.
- The Chilean telecommunication services market recorded revenues of \$4.3 billion in 2023, representing a negative compound annual growth rate (CAGR) of 5.3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.8% between 2018 and 2023, reaching a total of 38.8 million subscriptions in 2023.
- The growth in the market is also attributed to the increase in mobile penetration. According to the World Bank, mobile penetration in Chile reached 135.7 per 100 people in 2023, an increase of 0.7% from the previous year.
