- Market consumption volume increased with a CAGR of 5.9% between 2018 and 2023, reaching a total of 3,043.3 million subscriptions in 2023.
- The growth in the market is attributed to the increase in mobile penetration. According to the World Bank, mobile penetration in China reached 125.8 per 100 people in 2023, an increase of 0.8% from the previous year.
