- The Danish telecommunication services market recorded revenues of \$3.1 billion in 2023, representing a negative compound annual growth rate (CAGR) of 2.7% between 2018 and 2023.
- The market consumption volume increased with a CAGR of 1.4% between 2018 and 2023, to reach a total of 14.1 million subscriptions in 2023.
- The expansion of Denmark's telecommunications services market in 2023 is largely due to the rising proportion of internet users. According to the World Bank, the percentage of internet users in the country grew to 98% in 2023.
