- The Egyptian telecommunication services market recorded revenues of \$4.5 billion in 2023, representing a compound annual growth rate (CAGR) of 7.8% between 2018 and 2023.
- The market consumption volume increased with a CAGR of 6.5% between 2018 and 2023, to reach a total of 147.5 million subscriptions in 2023.
- In 2023, the telecommunications services market in Egypt experienced a contraction primarily due to its high penetration rate. With a large number of consumers already using telecommunications services, there is limited potential for new subscriber growth.
