- The Filipino telecommunication services market recorded revenues of \$7.6 billion in 2023, representing a compound annual growth rate (CAGR) of 4.5% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 1% between 2018 and 2023, reaching a total of 139.8 million subscriptions in 2023.
- In 2023, the market value declined due to market saturation and reduced opportunities for customer acquisition. This led to intense competition among service providers, who used aggressive pricing strategies and discounts to retain their customer base.
