- The Singaporean telecommunication services market recorded revenues of \$2.7 billion in 2023, representing a negative compound annual growth rate (CAGR) of 3.3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 3.4% between 2018 and 2023, reaching a total of 15.1 million subscriptions in 2023.
- The growth in the market is attributed to the increase in mobile penetration. According to the World Bank, mobile penetration in Singapore reached 170.3 per 100 people in 2023, an increase of 0.4% from the previous year.
