- The market consumption volume increased with a CAGR of 3.4% between 2018 and 2023, to reach a total of 129.7 million subscriptions in 2023.
- In 2023, the telecommunications services market in South Africa experienced a contraction primarily due to economic challenges, including inflation and slow GDP growth, which have strained consumer spending and investment in telecommunications infrastructure.
