- Market consumption volume increased with a CAGR of 2.4% between 2018 and 2023, reaching a total of 592.3 million subscriptions in 2023.
- The growth in the market is also attributed to the increase in mobile penetration. According to the World Bank, mobile penetration in Chile reached 135.7 per 100 people in 2023, an increase of 0.7% from the previous year.
