Overall, baby food in Norway is projected to see a further moderate decline in retail volume sales in 2024, although "other" baby food and milk formula are set to buck this trend. In retail current value terms, baby food is expected to see strong growth across the board, albeit slower than in 2023 as the rate of inflation and unit price increases slow.
