That being said, plant-based dairy is expected to register the highest current value and volume growth among all dairy and alternatives in 2024. Value sales are largely driven by younger consumers of under 40-years-of-age, who consider plant-based products to be healthier and less damaging to the environment, though the high prices is an obstacle.
