- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The fish & seafood industry within the NAFTA countries had a total market value of \$19,948.8 million in 2023. The Mexico was the fastest growing country, with a CAGR of 12.7% over the 2019-23 period.
- Within the fish & seafood industry, the US is the leading country among the NAFTA bloc, with market revenues of \$12,155.7 million in 2023. This was followed by Mexico and Canada, with a value of \$4,934.6 and \$2,858.5 million, respectively.
- The US is expected to lead the fish & seafood industry in the NAFTA bloc, with a value of \$13,109.7 million in 2028, followed by Mexico and Canada with expected values of \$7,480.0 and \$3,189.4 million, respectively.
