- Within the foodservice industry, China is the leading country among the BRIC nations with market revenues of \$8,72,080.4 million in 2023. This was followed by India, Brazil and Russia with a value of \$1,48,295.4, \$1,11,543.0, and \$12,629.5 million, respectively.
- China is expected to lead the foodservice industry in the BRIC nations with a value of \$10,47,897.7 million in 2028, followed by India, Brazil, Russia with expected values of \$2,18,242.9, \$1,44,534.5 and \$17,258.6 million, respectively.
