- Among the G8 nations, the US is the leading country in the foodservice industry, with market revenues of \$14,38,096.0 million in 2023. This was followed by Japan and France, with a value of \$1,61,461.8 and \$1,53,499.7 million, respectively.
- The US is expected to lead the foodservice industry in the G8 nations with a value of \$16,83,106.9 million in 2016, followed by Japan and France with expected values of \$2,44,033.7 and \$1,83,325.6 million, respectively.
