- Among the G8 nations, the US is the leading country in the mobile phones industry, with market revenues of \$209.9 billion in 2023. This was followed by Japan and Germany, with a value of \$52.7 and \$21.4 billion, respectively.
- The US is expected to lead the mobile phones industry in the G8 nations with a value of \$245.4 billion in 2016, followed by Japan and Germany with expected values of \$62.6 and \$29.9 billion, respectively.
