- Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the publishing industry and had a total market value of \$81,432.4 million in 2023. India was the fastest growing country with a CAGR of 1.7% over the 2019-23 period.
- Within the publishing industry, China is the leading country among the BRIC nations with market revenues of \$53,052.3 million in 2023. This was followed by India, Brazil and Russia with a value of \$24,445.0, \$2,292.9, and \$1,642.1 million, respectively.
- China is expected to lead the publishing industry in the BRIC nations with a value of \$60,271.9 million in 2028, followed by India, Brazil, Russia with expected values of \$30,184.6, \$2,446.6 and \$1,902.6 million, respectively.
