- Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the telecommunication services industry and had a total market value of \$517.7 billion in 2023. India was the fastest growing country with a CAGR of 12.5% over the 2019-23 period.
- Within the telecommunication services industry, China is the leading country among the BRIC nations with market revenues of \$430.7 billion in 2023. This was followed by India, Brazil and Russia with a value of \$39.7, \$30.2, and \$17.1 billion, respectively.
- China is expected to lead the telecommunication services industry in the BRIC nations with a value of \$460.9 billion in 2028, followed by India, Brazil, Russia with expected values of \$47.3, \$39.5 and \$20.1 billion, respectively.
