- Within the utilities industry, China is the leading country among the top 5 emerging nations, with market revenues of \$1,405.8 billion in 2023. This was followed by India and Brazil with a value of \$200.9 and \$102.1 billion, respectively.
- China is expected to lead the utilities industry in the top five emerging nations, with a value of \$1,774.2 billion in 2028, followed by India and Brazil with expected values of \$240.4 and \$119.4 billion, respectively.
