- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The home & garden product retail industry within the NAFTA countries had a total market value of \$8,83,543.6 million in 2023. The Mexico was the fastest growing country, with a CAGR of 9.6% over the 2019-23 period.
- Within the home & garden product retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$8,00,015.0 million in 2023. This was followed by Canada and Mexico, with a value of \$47,517.1 and \$36,011.6 million, respectively.
- The US is expected to lead the home & garden product retail industry in the NAFTA bloc, with a value of \$8,97,184.7 million in 2028, followed by Canada and Mexico with expected values of \$57,625.3 and \$41,129.4 million, respectively.
