The suncare industry within the NAFTA countries had a total market value of \$3,407.6 million in 2023. The US was the fastest growing country, with a CAGR of 7.1% over the 2019-23 period.
- Within the suncare industry, the US is the leading country among the NAFTA bloc, with market revenues of \$3,110.3 million in 2023. This was followed by Canada and Mexico, with a value of \$168.3 and \$129.1 million, respectively.
- The US is expected to lead the suncare industry in the NAFTA bloc, with a value of \$3,721.0 million in 2028, followed by Canada and Mexico with expected values of \$203.9 and \$171.9 million, respectively.
