Aerospace sealant is a class of adhesive used to restrict the passage of gases, fluids, and contaminants through seams, joints, or gaps in aerospace structures. The unique formulation of these sealants is able to sustain extreme situations such as high pressure, temperature, and exposure to different chemicals & environmental factors. Aerospace sealants are critical for maintaining the integrity of fuel systems & pressurized cabins and protecting sensitive components from damage.□

The constantly expanding aerospace industry is a key driver of the aerospace sealants market. In addition, increase in the maintenance, repair, and overhaul activities in the aerospace industry is significantly boosting the demand for sealants. Rise in expenditure toward the maintenance of military fleets further propels the growth of the market. With surging demand for high-performance, lightweight materials, the integration of nanotechnology in the formulation of aerospace sealants is an emerging trend, poised to drive the market in the future.□

However, aerospace sealants comprise of volatile organic compounds (VOCs) and other hazardous compounds, which are subject to stringent environmental regulations. In Europe, the Directive 1999/13/EC has stipulated certain operating conditions for installations and implemented emission limits for VOCs to regulate their effect on human health and the environment.□
