- This rising consumer confidence is a key driver for the apparel retail industry, as consumers are more willing to spend on clothing and fashion items that enhance their lifestyle. According to the European Commission, consumer confidence in Romania reached -18.3 points in August 2023, up from -30.4 points in August 2022.
