- The decline in the South African apparel retail industry in 2023 can be attributed to the significant drop in disposable income, which has intensified the industry's challenges. Eurostat reports that the net household disposable income of South Africa stood at \$192.7 billion in 2023, a decline of 4.9% from the previous year.
