- The European Baby Personal Care market had total revenues of \$9,958.8 million in 2023, representing a compound annual growth rate (CAGR) of 3.9% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.7% between 2018 and 2023, to reach a total of 1,406 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.4% for the five-year period 2023-28, which is expected to drive the market to a value of \$12,341.0 million by the end of 2028.
