The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Indian Baby Personal Care market had total revenues of \$1,399.7 million in 2023, representing a compound annual growth rate (CAGR) of 10.3% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 6.3% between 2018 and 2023, to reach a total of 579.7 million units in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7.7% for the five-year period 2023-28, which is expected to drive the market to a value of \$2,032.2 million by the end of 2028.
