The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2023 exchange rates.
- The Dutch Baby Personal Care market had total revenues of \$310.7 million in 2023, representing a compound annual growth rate (CAGR) of 0.5% between 2018 and 2023.
- Market consumption volumes declined with a CAGR of -2.2% between 2018 and 2023, to reach a total of 27.8 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.1% for the five-year period 2023-28, which is expected to drive the market to a value of \$327.4 million by the end of 2028.
