- The US Baby Personal Care market had total revenues of \$10,339.3 million in 2023, representing a compound annual growth rate (CAGR) of 4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.2% between 2018 and 2023, to reach a total of 964 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.1% for the five-year period 2023-28, which is expected to drive the market to a value of \$13,243.4 million by the end of 2028.
